

## WEEKLY SHARE REPURCHASE PROGRAM TRANSACTION DETAILS

SBM Offshore reports the transaction details related to the repurchase of its common shares made for the period December 12, 2016 through December 16, 2016.

The repurchases were made under the EUR 150 million share repurchase program for share capital reduction purposes and, to a lesser extent, for employee share programs. As of December 31, 2015, Group companies employed approximately 7,000 people worldwide. Full time company employees (4,900) are spread over five regional centers, eleven operational shore bases and the offshore fleet of vessels.
