

## WEEKLY SHARE REPURCHASE PROGRAM TRANSACTION DETAILS

November 14, 2016

SBM Offshore reports the transaction details related to the repurchase of its common shares made for the period November 7, 2016 through November 11, 2016.

The repurchases were made under the EUR 150 million share repurchase program for share capital reduction purposes and, to a lesser extent, for employee share programs. The Company's main activities are the design, supply, installation, operation and the life extension of Floating Production, Storage and Offloading (FPSO) vessels. These are either owned and operated by SBM Offshore and leased to its clients or supplied on a turnkey sale basis.

As of December 31, 2015, Group companies employed approximately 7,000 people worldwide. Full time company employees (4,900) are spread over five regional centers, eleven operational shore bases and the offshore fleet of vessels.
